INTRODUCTION

As part of its mission "to preserve, to interpret, and to appropriate the spiritual vitality" of the Evangelical United Brethren Heritage, the Center has conducted two major oral history projects. The "Grassroots Voices" project was the second and largest of these. Between 2002 and 2006, Center members and friends conducted more than 250 interviews with former EUB clergy and laity. The project's interviews, transcriptions, and supporting documents are available for use as Historical Collection 65: "Grassroots Voices: The EUB Experience" Oral History Collection.

The collection currently consists of two boxes (1 linear ft) of materials organized into five series:

Series 1:	Project Guidelines and Resources
Series 2:	Steering Committee
Series 3:	Recordings
Series 4:	DePauw University Archives
Series 5:	Transcriptions and Notes

The oral history interviews in HC-65 were created by the Center for the Evangelical United Brethren Heritage. All legal rights reside with the Center.

DePauw University Archives staff and students have played a major role in transcribing the "Grassroots Voices" interviews. The work of transcription is ongoing (2006).

HISTORICAL BACKGROUND

"Grassroots Voices: The EUB Experience" was conducted and managed by volunteers. Lorraine Esterly Pierce served as project Director. The stated purpose of the project was: "From as broad and balanced a perspective as possible to capture and preserve the memories of common – ordinary Evangelical United Brethren ministers and laity regarding what their church was for them and how it affected their lives." The focus of the project was "on remembered perceptions of every dimension of church life... through description of persons, practices, customs, ceremonies, social and architectural structures and arrangements, attitudes, rules of conduct and what not." The steering committee carefully selected lay and clergy subjects from across the United States who were long-time participants in the life of the former denomination.

SCOPE AND CONTENT

Series 1, Project Guidelines and Resources, contains papers defining the project and guiding the selection of subjects, guidelines on how to conduct oral history interviews, and copies of forms used by interviewers. Steering Committee reports are filed in Series 2. Series 3, Recordings, consists of the audio recordings of Grassroots Voices project interviews. Series 4, DePauw University Archives, includes correspondence and electronic transcription discs. Interview notes and transcriptions constitute Series 5.
